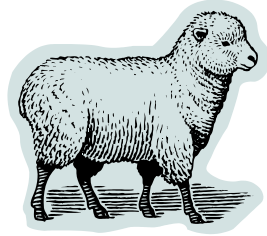

SITE DIRECTIONS:

Since most people utilize Map Quest, a GPS or have been to the site before I will give a general idea of how to get here but for details drop me an email or give me a call.

From Denver: take I-25 south to Interquest Parkway east to Powers Blvd south to Woodmen Rd east to Hwy 24, than follow directions below from the east.

From Pueblo: take I-25 north to Hwy 24 EAST, this will jog onto Powers Blvd north (left) and then jog again east on to Platte / Hwy 24 heading east. Follow directions below from the east.

From the West take Highway 24 eastbound to Judge Orr Road (traffic light), which is just a few miles east of the town of Falcon, head east (right) on Judge Orr, cross over Ellicott Hwy (stop sign) continue to Soap Weed Rd, take a right heading south to Mid Jones Road, turn left (east), site is about 1 mile on the right, white house, white garage, white barn near road and steel barn. If you go too far you will cross Calhan Road

From the East: take Highway 24, to Calhan, take Calhan Hwy south from Hwy 24 (on the east side of town), cross over Judge Orr Rd (stop sign) onto Calhan Road (dirt) which curves (be careful) take right on to Mid Jones Rd, site is second place on the left. From Calhan/Hwy 24 to site is about 10 miles.
